If you are a United Kingdom taxpayer you can help the Heritage Centre even further by allowing the JWS to reclaim the income tax paid on your subscription.

#### Aid Declaration.

We can only reclaim tax at the basic rate event if you pay tax at the higher rate but you can obtain further tax relief in your annual self assessment tax return.
